1 Application to become a WAMIF Account Holder

- (a) The applicant named in the Registration Form annexed to this Application as Annexure A (**Registration Form**) meets any eligibility criteria determined by WAMIF from time to time and applies to WAMIF to become an Account Holder on the Terms and Conditions annexed to this Application (**Terms**).
- (b) An application to be a WAMIF Account Holder will only be accepted if:
 - (i) the Account Holder agrees to be bound by the Terms;
 - (ii) a booking of a vehicle by the Account Holder pursuant to these Terms is for the Purpose described in the Terms; and
 - (iii) the Account Holder completes all parts of the application form/s that WAMIF deems required including the Registration Form
- (c) WAMIF reserves the right to refuse any application to become an Account Holder at its discretion.

2 Application to become a WAMIF Authorised Driver

- (a) The Account Holder wishes to apply for authorisation for those persons described in the Registration Form to be listed as an Authorised Driver of the Account Holder.
- (b) An application to be an Authorised Driver of an Account Holder can only be accepted if:
 - (i) the Authorised Driver(s) agrees to be bound by these Terms;
 - (ii) the Authorised Driver(s) completes all parts of the application forms that WAMIF deems required information; and
 - (iii) the Authorised Driver(s) gains authority from the Account Holder to be linked to an Account Holder's account.
- (c) An individual may be both an Account Holder and an Authorised Driver. An organisation is an Account Holder only.
- (d) An Account Holder may have more than one Authorised Driver on its WAMIF account.

- (e) WAMIF reserves the right to refuse any application to become an Authorised Driver of an Account Holder at its discretion.

3 Acceptance

- (a) WAMIF may accept this Application expressly in writing or impliedly by conduct (including by allowing access to the Vehicle to the Applicant after receipt of this Application).
- (b) WAMIF may not accept this Application until the Application is completed and signed by the Applicant (in Part 6 below) as required by WAMIF.

4 Registration Form

The Account Holder:

- (a) Must provide all information requested in the Registration Form;
- (b) Warrants that that information is true and correct in all respects; and
- (c) Agrees to notify WAMIF as soon as reasonably practicable if any of the information contained in the Registration Form changes at any time after acceptance of this Application by WAMIF. Acceptance of any change in Authorised Drivers is subject to the approval of WAMIF at its sole discretion.

5 Privacy Act

WAMIF operates in accordance with the *Privacy Act 1988*.

6 Agreement and Signature of Account Holder

By signing this Application, the Account Holder represents and warrants to WAMIF that all information in this Application is accurate and correct and is supplied for the purposes of obtaining access to the pool of Vehicles owned by WAMIF from time to time as reasonably required. The Account Holder also agrees that all Vehicles supplied by WAMIF to the Account Holder and/or Authorised Driver(s) at any time will be supplied on the annexed Terms and the Special Conditions Part 7 below, and accepts those terms and conditions.
